44th PATRONAGE REBATE PAID

The Board of Directors of the Luseland Credit Union have declared a Patronage on all Loan and Line of Credit interest paid and all interest earned on Plan 24, Regular Savings and Term Deposits in 2022 totaling \$250,000.00. The Patronage will be credited to the members' accounts on Tuesday, Feb. 7th. The Luseland Credit Union has a long history of patronage payments and the total paid back to members over the past 10 years is over \$1.5 million dollars!

Board members are elected at the annual meeting for a three-year term and can choose to let their name stand for additional terms if they wish. Did you know that you can set up direct deposits and automatic withdrawals with our downloadable void cheque? Follow the instructions below:

Online Banking:

1. Sign into your online banking on a desktop computer or tablet.
2. Click on 'Accounts' on the top grey menu bar.
3. Click on 'Download void cheque'.
4. Select the account.
5. Click 'Export' to open and save it as a PDF.

Mobile App:

1. Sign into your mobile app.
2. Select 'Activity' on the bottom menu.
3. Choose 'Download void cheque'.
4. Select the account.

LCU SCHOLARSHIPS



Each year LCU gives out three scholarships to deserving students. The LCU University Scholarship is awarded to a student attending a four-year University program and consists of \$4,000. The Trades and Technical School Scholarship is awarded to a student attending a technical and/or trades school and consists of \$2,000. The final scholarship awarded is the Victor J Delhommeau Scholarship and it is awarded to a student attending post-secondary school, that shows the most concern for the community, and consists of \$2,000. DID YOU KNOW you can 'favorite' ♥ a transaction (transfer, bill payment, or Interac e-Transfer®) that you plan to conduct often? By using favorites, you can select the transaction you want to complete without having to fill in all the details each time.

*NOTE: To create a favorite transaction, the transaction must first be completed.

Online Banking:

1. Sign into online banking on a desktop computer or tablet.
2. After completing the transaction, click on the 'favorite' icon (heart ♥ with the [+] symbol).
3. Give your favorite a name and click 'Add to favorites'.
4. You will receive a successful verification message.

Mobile App:

1. Sign into online banking on the mobile app.
2. After completing the transaction, click on the 'favorite' icon ♥ (heart symbol).
3. Give the favorite a name and click 'Confirm'.
4. You will receive a successful verification message.
