Due to the increased instances of debit card fraud, card transactions may be blocked in certain countries, including some states in the US. Please notify us of any out of country travel plans, particularly if you are travelling to the US. We will make every effort to ensure you have no debit card issues while you are travelling.

MemberCard Buyer Protection

You are protected every time you use your MemberCard debit card!!!

The program is simple! No forms to fill out, no applications and no extra cost!

- Home or home-based business purchases are protected
- Up to **\$60,000** lifetime
- Gifts (**without** recipient limitations)
- **No limits** on valuables
- Any MemberCard Debit Card member is covered, not just Canadian residents
- **World-wide** purchases, not just Canadian purchases
- If you have a MemberCard Debit Card, purchases made with a **cheque** drawn on the same account are also protected

Buyer Protection

Offers protection on the purchase of most retail items - including gifts! The item is protected for a full 90 days after the purchase, if it has been stolen, broken, or even consumed in a fire.

Valid claims will be satisfied either by replacing the lost or damaged item, or by a cash payment not to exceed the amount of the total purchase price.

Extended Warranty

The warranty period of a purchased item is doubled up to one entire year, as long as the manufacturer's warranty is valid in Canada for five years or less.
